

# Ethics and Professional Responsibilities for Court Interpreters

## Workshop Saturday, July 22, 2017

The Delaware Administrative Office of the Courts is pleased to offer a 1/2-day Court Interpreter Workshop on **Ethics and Professional Responsibilities for Court Interpreters**.
