ORDER

This 30th day of September 2014, after careful consideration of the appellant's opening brief, the appellee's motion to affirm, and the record below, we find it manifest that the judgment below should be affirmed on the basis of the Superior Court's order, dated June 6, 2014, adopting the well-reasoned report and recommendations of the Commissioner, dated April 3, 2014.
