- A. That all law-enforcement agency records and court records relating **only to** Case ID # _____, and charge or set of charges related to that case(s), be expunged and removed from the files and placed in the control of the supervisor of the State Bureau of Identification as provided for in 11 *Del. C.* § 4372(e)(1).
- B. That copies of this Court’s Order be delivered to the Petitioner or Petitioner’s Attorney, the Delaware Department of Justice, and the State Bureau of Identification, pursuant to 11 *Del. C.* § 4372(e)(1).
- C. That the Department of Justice and the courts of the State of Delaware take appropriate steps to see that all records not destroyed pursuant to this Order be handled in such a manner as to ensure that such records not be open to public inspection or disclosure.
- D. That it shall not be necessary for the Petitioner to disclose that he or she was arrested, charged, or convicted in Case ID # _____, and charge or set of charges related to that case(s), for any reason except as provided under 11 *Del. C.* § 4376(a).

IT IS FURTHER ORDERED, that as to Case ID # _____ and the charge of set of charges related to that case, that the Petition is DENIED for the following reasons:

- A. The Court finds that the case(s), and the charge or set of charges related to that case(s), is not eligible for expungement.
