Remote Parent Education Classes Now Available

The Department of Services for Children, Youth and Their Families (DSCYF) has given approval to multiple in-state providers now allowing them to offer remote parent education programs. The in-state providers now offering remote learning opportunities are: **Blackbird Forrest Counseling & Education Center, Lewes Counseling, Child Inc., and Jewish Family Services**. Contact information for each of the providers can be found on the attached information sheet from DSCYF.

The remote learning opportunities offered by these providers will be available through Zoom. The use of Zoom will allow the providers to engage live with the parent participants. With these offerings, parents have an expanded ability to access the required parent education from their homes. These programs also join the previously approved computer-based courses available through Online Parenting Programs. As a reminder, parent education is required for all parents in divorce cases with children up to the age of 17, all parents who are a party to a custody proceeding, and any parent in a visitation proceeding if the opposing party is also a parent of the child.

Parents (Petitioner and Respondent) must take an approved Basic seminar that will teach them about what children go through when their parents do not live with each other or their parents' divorce. Parents (Petitioner and Respondent) who have been involved in domestic violence must attend the domestic violence seminar that provides information about how domestic violence harms children and how to prevent it.
